A Civil Society Learning and Advocacy Programme on Health Financing in Africa





# IN SUMMARY

Joint Learning Agenda is a joint learning program on health financing and Universal Health Coverage (UHC).

This program was established through a consortium of global health organizations - the Global Financing Facility (GFF), the Global Fund, the Partnership for Maternal, Newborn and Child Health, WHO, the World Bank, GAVI, and CSU2030 - coordinated by regional civil society partners - Impact Santé Afrique (ISA) and WACI Health.

Started two years ago, more than 400 civil society organizations (CSOs) in 20 English-and French-speaking countries in sub-Saharan Africa have been trained: Benin, Burkina Faso, Cameroon, Chad, Ivory Coast, Democratic Republic of Congo, Ethiopia, Ghana, Kenya, Madagascar, Malawi, Mozambique, Liberia, Niger, Nigeria, Senegal, Sierra Leone, Tanzania, Togo, and Uganda

Creating a movement to drive real change for the betterment of people by getting governments to fund and implement quality health care for all by all is the main goal of the JLA program.

The program had two phases and three pillars: a learning/training phase for CSOs on health financing advocacy, followed by an implementation phase.

#### Phase 1 - LEARNING:

#### • PILIER 1:

Regional (Anglophone and Francophone) online Training of Trainers.

#### • PILIER 2:

In-country practical and action oriented trainings focusing on building CSO's capacity on advocacy and accountability for health financing for UHC.

#### Phase 2 - SUPPORT :

#### PILIER 3:

Putting learning into practice with the support of tailored capacity building, technical assistance, mentoring and grants.

This monthly newsletter will allow us to follow the evolution of the advocacy activities carried out by the CSOs trained in their countries during Phase 2. But first, let's start with a summary of Phase 2

## SUMMARY AND EXPECTATIONS OF PHASE 2

Phase 2 of the JLA program aims to intensify its support to all 20 countries enrolled in the JLA program since the first Phase. Participants will put their learning into practice by implementing their advocacy and accountability plans of health financing priorities for their countries.

In the last quarter of 2022, Trainers from participating countries have finalized their national advocacy and accountability plans and organized sessions to validate them by other local CSOs enrolled in the JLA program. JLA CSOs have actively participated in advocacy for health and UHC financing in their countries according to their advocacy and accountability plans (respond to calls for proposals for grants or research opportunities, participate in information and training webinars for partners, and started implementing their advocacy on health and UHC financing).

In this newsletter we will see during the months of November and December 2022 :

- CSOs were able to not only build their capacity to develop advocacy and accountability plans, but also finalize and validate the plans
- The program has seen the birth of a new collaboration
- High-impact actions were carried out to mark International Universal Health Coverage Day on December 12, 2022.



# COACHING TO STRENGTHEN CSO CAPACITY

In order to help CSOs finalize their advocacy and accountability plans, the coordinating organizations, ISA and Waci Health, proceeded to strengthen their capacities on the development of an advocacy and accountability plan on health financing via a coaching webinar.

During this coaching, in order to better respond to the specific expectations of the countries, 3 sessions per group of 3 to 4 countries were organized.

Country focal points were provided with key recommendations and tools to help them develop their advocacy and accountability plans on health financing.

This coaching was a great success. Organized before the validation workshops for the advocacy and accountability plans, it brought the CSOs up to speed on the expectations of an advocacy and accountability plan. It also allowed them to be effective during the validation workshops.


The validated plans were finalized, reviewed, and transmitted to the partners.

# BIRTH OF A COLLABORATION WITH A KEY PARTNER: POPULATION ACTION INTERNATIONAL (PAI)

Population Action International (PAI), an international non-governmental organization and the GFF CSO Host launched two funding opportunities in November 2022 to support country-level advocacy on GFF policies and funding, and to monitor progress and encourage accountability for quality, access and equity. The deadline for registering for these grant offers was 04 December 2022. These funding offers were an opportunity for JLA CSOs to access funds needed to implement their advocacy and accountability activities.

On 29 November 2022, the CSOs in the program were given an information webinar on the mechanism for awarding these grants. This was an opportunity for CSOs to exchange directly with the PAI partner and submit their applications for the grants offered by PAI.

Of the sixteen countries that applied, five projects were selected: Burkina Faso, Senegal, Chad, Ethiopia and Malawi. Other applications are put on hold for the next round of grants expected in Q1 of 2023.

#### Benin: A high-level panel on CSU

On 08 December 2022, the Benin Coalition of CSOs for Universal Health Coverage (COBCUS) participated in a panel discussion on the theme «Place of Universal Health Coverage in the second Government Action Programme (PAG II)». The Ministry of Health, the National Agency for Social Protection and the Private Health Sector Platform, and the Centre for Research in Human Reproduction and Demography (CERRHUD) were present at this panel.

#### Ethiopia: A high-level panel on health

On 20 December 2022, the UHC Coalition participated in a panel discussion with the Minister of Health, his team of relevant directorates, the delegate from the Ministry of Women and Social Affairs, the Deputy Director of the Ethiopian Health Insurance Agency, partner organizations such as Save the Children, JSI and CSO members of the Consortium of Christian Relief and Development Associations (CCRDA) and the Consortium of Reproductive Health Associations (COHRA).

Under the theme «Building the world we want: a healthy future for all», the highly interactive discussions were led by five high-level experts from the Ministry of Health, the health insurance agency, and the partner organizations involved in this program.



#### Malawi: Media coverage of the CSU International Day

The Health and Rights Education Programme (HREP Malawi) and WACI Health together with the Malawi media celebrated Universal Health Day 2022 in Blantyre, Malawi, which was attended by leading Malawian media such as the Malawi Broadcasting Corporation (MBC, the national broadcaster), the Nation newspaper, The Times News 360, ZODIAK Broadcasting Cooperation, Capital Radio, among others.

# HIGH IMPACT ACTIVITIES FOR A UHC ON THE MOVE



Senegal: Participation in the 5ème of the Galien Forum whose theme was Universal Health Coverage

From December 6 to 10, 2022, the CSOs of the JLA program participated online via Zoom and YouTube in the fifth consecutive year of the Galien Africa Forum held on Senegalese soil. During these days, Dakar was the African capital of health, innovation and leadership of women and youth.

Placed under the effective presidency of His Excellency, Mr. Macky SALL, President of the Republic of Senegal, for the 2022 edition of the Galien Africa Forum, the central theme chosen is «Accelerating Africa's march towards Universal Health Coverage».

Ivory Coast: A regional mobilization for children under 5 and women of childbearing age

A regional workshop on nutrition and health issues for children under 5 years of age and women of childbearing age was organized at ASAPSU, a member of the JLA program, in December 2022. Several countries participated in this workshop, namely Cameroon, Ivory Coast, Tunisia, and Tanzania. The workshop was highlighted by the presentation of a study conducted by Côte d'Ivoire on these countries. The representatives of the Presidency of the Republic and the Ministry of Health, Public Hygiene and Universal Health Coverage were present at this workshop. The resolution taken during this meeting is that the civil society must mobilize during the next summit of the Heads of State in Ethiopia in order to plead for better financing of the nutrition of children of less than 5 years and women of childbearing age.





Kenya: A Civil society advocacy charter for the coalition was developed and shared on 29 December 2022.

The purpose of the civil society and private sector health financing advocacy consortium is to actively advocate: More money for health -(10% progressive annual increase in the national health budget towards attaining 15% of national budget and 5% of GDP to health), More health for the money (efficiency and better use), Increased equity and financial protection, Improved leadership, governance, and coordination of the health financing process and is aligned to the African Union leadership commitments and the consortium's joint advocacy plan. The civil society coalition charter will be reviewed and adopted during a first workshop in January. Civil society will adopt the civil society health financing advocacy coalition charter and accelerate its legal and administrative hosting process.



Malawi: Certificates hand over on Universal Health Coverage (UHC) Health Financing Training for twenty one Malawi Non – State Actors, on December 23rd

"Civil Society Organizations (CSO's) play a critical role in running affairs of government and also assist in delivering essential health services to the masses." Has declared the Principal Secretary in the Ministry of Health Dr. Charles Mwansambo, underlying the relevance of a health sector development strategy, that can produce tangible results through the involvement of more players. The training received by the 21 non-state actors, will help in supporting the capacity building of communities in Malawi on health financing and has also helped graduates to understand best practices and experience in relation to advocacy and accountability,

including identification of key stakeholders, allies and partners at country level in advancing health financing in Malawi.


